### **REGISTRAR & SHO IN REHABILITATION MEDICINE**

The National Rehabilitation Hospital (NRH) is the national tertiary referral centre in Ireland providing complex specialist rehabilitation services to adult and paediatric patients from throughout Ireland. At the NRH, services are delivered to patients who as a result of an accident, illness or injury have acquired a physical or cognitive disability, or both and require a specialist interdisciplinary programme of rehabilitation. Rehabilitation programmes at the NRH are delivered by consultant-led interdisciplinary teams in the following areas of specialty:

- **Brain Injury** (including traumatic and non-traumatic brain injury and stroke or other neurological conditions)
- **Spinal Cord System of Care** (including traumatic and non-traumatic spinal cord injury)
- **Prosthetic, Orthotic and Limb Absence Rehabilitation (POLAR)**
- **Paediatric Family-Centred Programme**

The NRH is undergoing major redevelopment and is nearing completion of phase 1 of the new National Rehabilitation Hospital Development Project. Services at the NRH are accredited by CARF (Commission for Accreditation of Rehabilitation Facilities), an internationally recognised, independent accreditation system.

The NRH is a fully publicly funded voluntary hospital and operates on the ethos of providing high quality care and treatment to patients irrespective of background or status, but on the basis of clinical need.

The hospital is located on the east coast of Dublin, approx 8 miles from the city centre, beside the sea, close to the picturesque Wicklow Mountains and equidistant to Dun Laoghaire and Blackrock town centres. The hospital is easily reached by a number of buses from the city centre and is situated close to a DART station.

Experience in Rehabilitation Medicine forms a component of training in **Neurology, Geriatric Medicine, General Medicine, Rheumatology and Palliative Care** and is excellent preparation for any career that involves chronic illness, including General Practice. These posts would be ideal for a candidate preparing for MRCP or preparing for a career in General Practice.
