





The National Rehabilitation Hospital (NRH) in Dun Laoghaire is the national tertiary referral centre for Ireland providing complex specialist rehabilitation services to adult and paediatric patients from all parts of Ireland in a range of CARF-accredited in-patient, out-patient and community programmes. The NRH is a publicly funded voluntary hospital and operates on the ethos of providing high quality care and treatment to patients based on clinical need, irrespective of background or status. The NRH is undergoing a major transformation of its facilities and services. Phase 1 of the redevelopment project has been fully operational since June 2020 and provides a unique, purpose-built facility that includes 120 single ensuite rooms with integrated therapy, clinical and social spaces.

Peamount Healthcare is an academic partner of Trinity College Dublin and is a recognised provider of rehabilitation, residential and community services in partnership with CHO7 and the Dublin Midland Hospitals Group. In August 2020 Peamount Healthcare opened 10 specialist neurological rehabilitation beds that represents the inpatient component of the first national Managed Clinical Rehabilitation Network within a new purpose built 100 bed facility (Aberdeen Centre).

This role provides an exciting opportunity for involvement of a Consultant in Rehabilitation Medicine in shaping the future of neurorehabilitation services in Ireland.

Peamount Healthcare, the National Rehabilitation Hospital and the Dublin Midlands Hospital Group have joined forces to deliver the first Managed Clinical Rehabilitation Network Demonstrator Project in line with service reconfiguration recommended in the NCPRM¹ Model of Care and the Neurorehabilitation Strategy Implementation Framework. After a successful pilot, funding has been approved to support the continuance and enhancement of the inpatient neurorehabilitation unit recently established at Peamount Healthcare as a key component of this demonstrator project.

This post will be one of 3 consultant posts supporting the delivery of specialist rehabilitation in this innovative service that aims to improve patient outcomes by providing safe, high quality, person-centred neurorehabilitation at an appropriate level of complexity.

The new consultant post will assist in delivering new and enhanced services across the Network including:

- New inpatient service (since August 2020) at Peamount Healthcare
- Enhanced out-patient / ambulatory services at the National Rehabilitation Hospital and Peamount Healthcare
- Patient consultations in hospitals within Dublin Midland Hospitals Group
